- (i) To render all kinds of help, assistance and guidance to the needy and poor people of the society and to engage in all types of philanthropic and charitable activities with particular focus on orphans, destitute widows, tribal people, old age people and other socially neglected people and to create necessary facilities with this object.
- (ii) To undertake mission oriented activities to provide medical treatment and assistance, to the needy patients/people and to provide Medical awareness/Education and to set up health centres/clinics with social commitment.
- (iii) Fight against Social evils, atrocities, Corruption, human right violations etc and to educate people on such social issues and their rights, laws etc and to conduct study camps, seminars, conferences and exhibitions for this and to provide all kinds of assistance to the needy people.
- (iv) To participate, create awareness, conduct campaigns and organize people and create forums and undertake activities to involve in socially relevant issues including Environmental awareness, pollution, Forestation and waste land management, human rights, HIV/Aids and other issues affecting general public or in public Interest.
- (v) To organise the general public particularly marginalised and unorganized people to create awareness among them and to undertake/assist them to undertaking activities/programmes/schemes for their common good
- (vi) To establish and promote, set up, run, maintain, assist, support and aid or help in the setting up and / or maintenance of Training Centres, vocational training centres, re-orientation centres, Rehabilitation centres and Educational institutions with a social objective.
- (vii) To publish, distribute magazines books, periodicals, texts, notebooks, study materials, audio/video, other electronic materials, create interactive website, on line publications, etc, for creating social awareness, social awakening, Legal

- awareness, brotherhood and dissemination of knowledge in line with the objectives of the trust.
- (viii) To engage in all kinds of activities for promotion of Culture, Arts and literature including films and to provide training, conduct camps, seminars and participative opportunities to the public
- (ix) To promote and protect Indian Traditional Art, music, knowledge etc. and create facilities for this and also promote handicraft, cottage Industries, and Khadi products.
- (x) To work for the welfare & support of families of martyrs and also for the welfare of the prisoners and their families
- (xi) To co-operate and participate with Governments, Governmental agencies, national and international Institutions, organisations, other NGO,s, Universities and Research Organizations etc for promoting the objects of the trust.
- (xii) To make donations subject to the rules and regulations under Income Tax Act, FCRA regulation and other applicable rules and laws, to other public charitable Trusts/ societies engaged in activities, which are in conformity with the objects of the trust and which are registered under the Income Tax Act.
- (xiii) The Trust shall not carry out/embark upon any activity in the nature of Trade, Commerce or Business, and shall not render any service in relation thereto or connected with it, under any circumstance.
